The Applicant hereby offers to settle both parties' motions scheduled for October 6, 2005, on the following terms:

1. The Order of the Honourable Justice Clark dated June 23, 2005, shall be varied as follows:
 - (a) varying the Respondent's every other weekend access to Friday at 7:00 p.m. to Monday mornings at 6:30 a.m.;
 - (b) varying the Respondent's Wednesday access times to 7 p.m. to 6:30 a.m. Thursday morning;
 - (c) varying the pick-up and drop-off location for the Respondent's access to the Country Style coffee shop located at the intersection of Highways 7A and 12 in Manchester;
 - (d) to permit the Respondent to attend within 500 metres of the matrimonial home solely for the purposes of picking-up and dropping-off the child at the Country Style coffee shop located at the intersection of Highways 7A and 12 in Manchester.
2. The Respondent shall be imputed with an income of \$25,000 for child support purposes.
3. The Respondent shall pay child support to the Applicant of \$222 per month in accordance with the


Federal Child Support Guidelines commencing April 19, 2005.

4. The Respondent shall receive a credit for \$685 in payments made since the date of separation.
5. The Respondent shall be prohibited from taking any further steps in the case until he has paid all arrears of child support owing to the Applicant under this Order.
6. The Respondent shall provide the disclosure requested in the Applicant's Request for Information dated September 16, 2005 within 15 days.
7. The Office of the Children's Lawyer shall be appointed to investigate and report on the issues of custody and access concerning the minor child of the marriage, namely Child born 2000.
8. The Respondent shall arrange to have the charge in favour of Brian Kenneth Evans Professional Corporation registered against the matrimonial home lifted immediately.
9. The matrimonial home known municipally as Matrimonial Home Address Ontario, shall continue to be listed for sale with Ernie Tiemes.
10. The Applicant shall return the "For Sale" signs previously placed on the front lawn by Ms. Tiemes to Ms. Tiemes within 30 days. If the Applicant does not comply she pay Ms. Tiemes the sum of \$150 to replace the signs.
11. The Respondent shall pay the Applicant's costs of this motion fixed in the amount of \$1,000.
